
COMMUNITY SERVICE OPPORTUNITY

CHAPTER HISTORY

The chapter was chartered on 17 November 2007. There were seven founding members with five of them Tennessee National Guardsmen: COL (R) John Lloyd, COL (R) William Wynns, COL (R) Frank Pointer, Ltc (R) Jim Henderson. & CW5 Gary Nokes; COL (R) Tom Sarver and MAJ (R) Dan Sullenger were the two additional founders, both of which are Marines Other early individuals who joined the chapter in October2007 are: William G. McAlister, Bernie S. Bass, J. Richard Colby, Danny C. Farmer, James R. Roberts, James T. Kardatzke, James C. Tanksley, Russell B. Driver, Henry S. Richards, Dorothy E. Jordan, Curtis H. Landers, Don R. Deering, Kent Russ, Andrew Waynick, Joseph C. Thomas, & Bruce R. Jones. They chose to meet the first Thursday of each month & the meeting be a luncheon one. The reasoning behind this date was that one of the founding members' wives had a church meeting at the same time so it was a convenient time for him! The luncheon meeting was decided because the founding members were retired & this time did not take away from family needs. The Chapter has met at McKendree Village in Hermitage since the beginning. The location at the complex has changed but the meetings have been there except for a brief period during COVID when the facility limited outsiders coming in. At that point, the meetings were held down the road in Hermitage at a local restaurant, Meatballs. Originally, McKendree even allowed the Chapter to go through the facility's cafeteria & eat with the residents. That was stopped after the Chapter returned following COVID.

LEGISLATIVE ACTION

The following Legislative action is taken verbatim from a letter from MG Vogel:

In this pivotal year for our nation's servicemembers and veterans, MOAA remains at the forefront in the fight for key legislative changes. Our spring campaign event, Advocacy in Action, saw hundreds of supporters from across the nation gathering on Capitol Hill to spotlight critical issues affecting the uniformed services and veteran communities.

MOAA is grateful to you and others who have engaged in our advocacy efforts through MOAA's Legislative Action Center. To sustain this momentum, we are urging you and our more than 360,000 members to engage with elected officials during the congressional summer recess. Legislators will be in their home states for the next month, providing a unique opportunity for personal outreach.

Key MOAA advocacy priorities:

- **Junior Enlisted Pay Raise:** Competitive pay remains critical to the health of the all-volunteer force, and both the House and the Senate seek to address this issue in the National Defense Authorization Act (NDAA). The House NDAA calls for servicemembers E-1 to E-4 to receive a 15% pay raise beyond the 4.5% earmarked for all in uniform. While the Senate version calls for an additional 1% increase for servicemembers E-1 to E-3 (beyond the 4.5% raise).
- Basic Allowance for Housing (BAH) Restoration: Access to quality housing and promoting financial wellness are important to sustaining the all-volunteer force. Restoring BAH addresses both issues. The House version of the NDAA would restore BAH to 100% for FY 2025 a move toward MOAA's goal of full repeal of the BAH reduction, but not a permanent fix. Unfortunately, the Senate version does not address the issue.
- Major Richard Star Act: Tens of thousands of combat-injured veterans lose a
 dollar of earned DoD retirement pay for every dollar of VA disability
 compensation. For three years in a row, over two-thirds of Congress has
 supported the Star Act, which would end that unjust financial offset. Despite this
 vast support, neither version of the NDAA includes the bill. However, it is critical
 lawmakers continue to hear about this important issue, especially as we
 approach the start of the 119th Congress.

Stay informed with upcoming updates through our <u>magazine</u> and The MOAA <u>Newsletter</u>, follow MOAA on <u>social media</u>, and watch our weekly <u>Advocacy Update</u> on MOAA's YouTube channel.

Your participation amplifies our collective voice in shaping policies that support our nation's servicemembers past and present, and their families. Thank you for your continued dedication to MOAA's mission.

SURVIVING SPOUSE REPORT

Who Is Best to Serve as an Executor?

One of the many important decisions when making an estate plan is whom to trust to be the executor (of the will) of the deceased's estate. Usually, the executor is named in the last will and testament and is likely the surviving spouse, adult child, a trusted family member, or a trusted friend. Sometimes the executor is an attorney, bank officer, or other impartial agent.

The person named for this important role should be asked if they are willing to assume responsibility and if they understand what the duty entails and what they will be responsible for when the time comes. The duty of executor can be a very complicated and time-consuming role, and no one should be "surprised" to learn they are the executor of an estate. The executor has a legal duty to act primarily for the benefit of another with duties involving good faith, trust, special confidence, and candor.

Many times, married couples just assume their spouse will be the executor of the estate, and that spouse might have no idea of the complexities and requirements, which can vary from state to state. A person who manages money or property for the deceased must exercise a standard of care as imposed by law or contract with specific responsibilities. The administration of an estate generally requires a fair amount of time and energy. Often compensation is allowed, and a court or commissioner of accounts must approve the compensation, which is often a percentage of the assets handled.

Some other duties of an executor include: • Understand the rules of probate (the official proving and recording of the will as the authentic and valid last will and testament of the deceased). • Know which asset types that do and do not pass through probate. • Keep assets under control as a fiduciary, separate from individual, personal and business assets. • Prepare a complete inventory of all assets in the estate (stocks, bonds, brokerage accounts, bank accounts, life insurance policies, real property, automobiles, and any other assets). Having a complete and accurate inventory of the assets enables the executor to properly manage the estate and satisfy all of the terms of the will. • Open a separate fiduciary (estate) bank account at a bank that can provide you with the original canceled checks or statements with images of all canceled checks. • Take possession of the assets of the deceased and inquire about safe deposit boxes and accounts they may have maintained. • Make an online search for any unclaimed property in the name of the deceased. • Close bank accounts and transfer funds in a separate account (create an estate account with a separate tax identification number). • Follow the disbursements to heirs as instructed in the will. • Document all transactions and prepare to file income tax. For more information on all the documents an estate plan might include, download MOAA's Estate Planning Guide.

CHAPTER MEMBER SPOTLIGHT LTG (Ret) John M. Pickler

A native of Chattanooga, Tennessee, John was graduated from the United States Military Academy and commissioned in the Field Artillery on 9 June 1965. After a series of company level assignments in the United States and Germany, coupled with combat duty with the 1st Cavalry Division in the Republic of Vietnam, he attended the University of Virginia and was awarded a Master of Science in physics in 1971, after which he served as an instructor and assistant professor in the Department of Physics at West Point for three years. Field grade duties included a series of command and operational staff positions in the United States, Turkey, and Germany, followed by an assignment to the Pentagon as the Executive Officer to the Chief of Staff of the Army. In 1990 John was promoted to brigadier general and stationed at Fort Carson, Colorado, as the Assistant Division Commander for Support of the 4th Infantry Division (Mechanized). After command of Joint Task Force Six at Fort Bliss, Texas, in 1991-93, he was promoted to major general and assigned to senior staff and command at Fort McPherson, Georgia, and Fort Bragg, North Carolina. John commanded Fort Carson from 1996 to 1997, and in October 1997 he was promoted to lieutenant general and assigned as the Chief of Staff and Deputy Commanding General of United States Army Forces Command. From August 1999 until his retirement in January 2002, John was Director of the Army Staff in the Pentagon. His awards include the Distinguished Service Medal, two Defense Superior Service Medals, five Legions of Merit, the Distinguished Flying Cross, two Bronze Star Medals (one with "V" Device), four Meritorious Service Medals, 19 Air Medals, and two Army Commendation Medals. Following his retirement from the Army, John joined Bechtel National, Inc. (BNI) in February 2002 and served as the Manager of Strategic Programs and Homeland Security until deploying to Iraq with BNI in April 2003. During his tour with the Iraq Infrastructure Reconstruction Program, John was initially the Manager of Liaison and Security Services and then the Deputy Program Manager for the project until his return to the United States in September 2004. After a six-month stint as a capture manager for a major DoD project, in April 2005 John became the President and Program Manager of Kwajalein Ranges Services, LLC, which provides space operations, logistical, and community services support to the

U.S. Army Kwajalein Atoll/Ronald Reagan Ballistic Missile Defense Test Site. John returned from Kwajalein in July 2007 and became the Senior Manager of Defense & Space Programs. In June 2011 John was assigned as the Program Manager of the Cooperative Threat Reduction Program until his retirement from BNI in June 2012. John and his wife, Karen, have been married for over 59 years and have one daughter, two sons, eight grandchildren, and five great grandchildren. Their youngest child is an Army colonel who has had five combat tours of duty in Iraq and Afghanistan and is currently assigned as the commander of the 1st Infantry Division Artillery at Fort Riley, Kansas.

So, recruiting 13 members of Kappa Sigma fraternity, Cumberland traveled to Geogia to take on Tech, one of the powerhouse teams in the country. The rest, as they say, is history.
