Council President Pete Warner began the meeting at 11:08 AM and led the pledge to the flag. Following the pledge of allegiance to the flag Chaplain Eddie Sumbler said a prayer of opening for the meeting.

**Acceptance of Minutes**

Minutes of the 15 January 2025 meeting had been sent out on 11 April 2025 to all the chapter presidents and Council members Kathy Desjarlais moved that the minutes be accepted. The motion was seconded by Doug Gilbert and approved unanimously

## **Financial Report**

The financial report for the period of January 1, 2025, to March 31, 2025.

The council had three disbursements during the quarter, to Pete Warner for travel expense visiting TN02 East Tennessee Chapter reimbursement of \$365.84 and incidentals to support the rebuilding of our East TN chapter of \$116.44. Marketing expense for east TN of \$235.96

The council had no deposit from MOAA National.

Total funds on hand at the end of the quarter were \$5,363.53, which included restricted travel funds of \$595.07.

Kathy Desjarlais moved that the Financial Report be accepted. The motion was seconded by Karon Uzzell-Baggett and approved unanimously.

The council accepted the Treasurer's report.

## **Surviving Spouse Report – Patricia Bergquist written update provided as follows:**

All Tennessee MOAA Chapters have provided their Surviving Spouse Liaison (SSL) information, except the East Tennessee Chapter. A Surviving Spouse Liaison may be a surviving spouse, spouse, or an officer in your chapter. Please update Patricia of any Surviving Spouse Liaison changes. ## **ADVOCACY/LEGISLATION**

- 1) H.R.2055 and S.611- "Caring for Survivors Act of 2025" sponsored by Rep. Johana Haynes (D-CT), Rep. Brian K. Fitzpatrick (PA-R) Sen. Richard Blumenthal (CT-D), and Sen. John Boozman (AR-R) are to expand Title 38, United States Code, to improve and expand eligibility for the Dependency and Indemnity Compensation (DIC) paid by the VA to surviving spouses and others whose veteran died on active duty or from a service-related injury/illness. This legislation would increase DIC from 43% of a single, 100% disabled veteran's compensation to 55%. The 2025 DIC flat rate is \$1,653.07 per month. Passage of these bills would mean an increase of \$454 per month per recipient and increase the DIC flat rate to \$2,107.07 per month. Since 1993, DIC has only been increased by Cost of Living Adjustments (COLA). This increase is needed by not only our aging surviving spouses, but our young surviving spouses raising children alone due to active-duty death, service-connected death, and suicide! Also, the bills would lower the 10-year requirement for a 100% veterans' rating to 5-years to award DIC for a non-service-connected death. Proportionate payments for 5-10 years of 100% rating. There are 506,492 DIC eligible surviving spouses as of December 31, 2024.

**H.R.2055 has 53 co-sponsors (1 TN: S. Cohen (TN-09))**  
**S.611 as 1 co-sponsors (NONE from TN)**

- 2) H.R.1004 and S.410 - "Love Lives on Act 2025", endorsed by over 50 Veteran Service Organizations, was introduced by Rep. Sen. Jerry Moran (KS-R) and Sen. Raphael Warnock (GA-D) with 22 original co-sponsors and Representatives Richard Hudson (NC-R), Joe Neguse (CO-D), Derrick Van Orden (WI-R), Kelly Morrison (MN-D), Morgan Luttrell (TX-R), and Ro Khanna (CA-D). Approximately 30,000 surviving spouse who receive benefits would be impacted positively by passage of this legislation.

Currently, surviving military spouses are not allowed to remarry before the arbitrary age of 55 without losing ALL their benefits.

Specifically, we understand the bill allows the following:

- Allows retention of Survivor Benefit Plan (SBP) through the Department of Defense at any age,
- Allows retention of Dependency and Indemnity Compensation (DIC) upon remarriage at any age;
- Allows remarried surviving spouses to regain their TRICARE benefits if their marriage subsequently ends due to annulment, divorce, or death.

**H.R.1004 has 45 co-sponsors (NONE from TN)**

**S.410 has 33 co-sponsors (NONE from TN)**

In the last Congress through the Sen. Elizabeth Dole 21<sup>st</sup> Century Veterans Healthcare and Benefit Improvement Act, three (3) of the provisions in the original bill passed into law:

- Allows remarried surviving spouses access to Commissary and Exchange benefits;
- Allows remarried surviving spouses to maintain eligibility for education benefits under Fry Scholarships (Chapter 33) upon remarriage; and
- Removes the “hold themselves out to be married” clause from 38 USC, Section 101, Paragraph 3, which could cause loss of survivor benefits.

*Note: Remarried surviving spouses who desire Commissary/Exchange access effective October 1, 2025 (per the bill) will be required to have proper ID. We are waiting for the Department of Defense to release the process for obtaining identification.*

Tragedy Assistance Program for Survivors (TAPS) under leadership of Ashlynn Haycock-Lohman, TAPS Legislative Director, continues to lead the charge to advocate on Capitol Hill, and keeps the Love Lives On Act of 2025 Facebook group focused on the e-mail campaign to U.S. Congressmen and Senators to garner co-sponsorship and support for the bill.

ADVOCACY:

While MOAA National only has these two pieces of legislation in its second or third priority tier, e-mail campaigns continue to both Congressmen and Senators across the United States to garner co-sponsors and support. Please encourage all MOAA chapter members and surviving spouses to contact their Congressmen and Senators to advocate for legislation impacting our surviving spouses as follows:

1. MOAA Dues Payment System
  - System Works well once you accomplish set-up. Set-up begins with your request to join the process (MOAA Council & Chapters). Once you have met C&C requirements then the Cheddar-up App process begins. It is not difficult but does require some time & effort.

  - The process is working for MTC and Chattanooga.
2. Committee Module (CM)
  - Chapter President & Membership Chair ONLY will have access to modify CM data.
  - Read the instruction sheet before you attempt to access the CM. [https://www.moaa.org/contentassets/67ca3ac4aa3c4ec49c59278940a6c090/cm\\_instructional-guide\\_v4.pdf](https://www.moaa.org/contentassets/67ca3ac4aa3c4ec49c59278940a6c090/cm_instructional-guide_v4.pdf)
  - Sign into MOAA.org (and yes you may be afforded the opportunity to change your password), then go to your Profile followed by Switch to Partner Portal. This will take you to a list of the TN Chapters and Council (FTCKY will see the same thing for KY Council & Chapters). Select your chapter and click on Show Community Group Member. This will take you to a listing of everyone that is shown as active in your Chapter. (For a list in alphabetical order hover over the last name and select the up arrow).

- **At this point read the instructions again.**

- You can modify individual member roles and activated/deactivated dates by selecting the member (button to the left of their row) and then selecting Show Community Group Member. This will provide the data MOAA is willing to share about each individual member and you can input for role, activation date and inactivation date.

- After scrolling through the member listing, you will identify that MOAA has not removed anyone that you reported as passing away (TAPS) since July 2024. You can remove these by entering the date they passed as their inactive date.

- New members were not always added as well. Return to the alphabetical list and choose new member. In the Contact field enter their MOAA Member #, or their email address. One of these should return their entry, allowing you to then enter an activation date as a “member”.

- You will note that on individual records there is a lot of data missing (address, phone numbers, etc.). This is information that MOAA expects each individual member to maintain in their profile, so we need to sue a gentle reminder to our Chapter members.

- Still a lot of questions/concerns to be addressed; it is a work-in-process. Please follow the process covered in the instructions to report questions/concerns to MOAA. And re-read the instructions again.

3. Near Real Time (NRT) Report.

- Another work-in-process, so review carefully before reaching out to everyone on the list. It still contains potential members who live outside individual Chapter cachement areas, as well as those who have reached ages that may preclude active participation

## **Chapter Updates**

2. January 13<sup>th</sup> - Chattanooga Chapter Board Meeting. Among several issues discussed it was agreed to move forward with the purchased of chapter D&O and General Liability Insurance. Total cost for both policies was \$ 1,100.

3. January 15<sup>th</sup> – Attended the TN Council Quartey Meeting by ZOOM.

4. January 21<sup>st</sup> - Monthly Chapter Spouses Lunch at the Chattanooga Golf and Country Club.

This revitalization of East Tennessee has been underway for quite a few years, and it took Pete's leadership to get it here in a better place, with the help of lots of folks. MOAA is the largest military advocate association in the United States, having more than 350,000 National members and for 18 years in a row have been on the list of the top ten advocates in Washington DC across the board for advocacies and are certainly the number 1 association for Veterans on the Hill and work very hard to maintain that status. We have 11 paid lobbyists on staff that work every single day on behave of the association. MOAA what do we do, in one sentence it would be "We champion and safeguard your benefits and promises made for all veterans and their families"

We have nearly 400 Affiliated chapters councils satellite chapters and went on to explain a few details of what the affiliates were. There are three areas that chapters really make a difference for us:

1. Membership – as seen today this is a perfect example of what we ask of chapters. To help grow membership within the chapter and National as we are doing today. We have 350,000 National members with only less than 35,000 belonging to chapters. We must get younger folk involved the average age of a MOAA member is about 64 the average age of chapter members is 76 we need to get relief on board we are going after 40–60-year group.
2. Advocacy – chapters are the state level advocacy and support for veterans.
3. Community – the work you do in the community

Thanking all of you for showing up today for MOAA, wanting to be a part of this chapter and a part of this MOAA mission.

Pete had invited some guest to explain their duties for this chapter, then introduced Don Thompson Mountain Empire Chapter President. Don had mentioned a book titled "Thank you for your Service" and found it interesting at who supports the military. Don introduced John Rice.

John Rice Mountain Empire Chapter Past President. Targeting the younger people 40 – 60 is important but do not leave out the younger people who do not know MOAA, we need to be educating them. He sees a great need for this program to be successful here and thank you for letting us come to talk to you today, you have a great opportunity here do not let it get past.

Pete introduced: Ray Mitchell Chattanooga Chapter President, who stated he brought Scott Hardin with him who is all about MOAA. MOAA helped us out with grant money by doing things out in the community if you have veteran related issues that fit the criteria, MOAA is pretty good about giving you money to support and help with those issues. Chattanooga is an older chapter and have struck out to find those younger members and have brought in about 10 members who are under the age of 60 this

year. We try to become more of a family we reach out and join with the community. He thanked Pete for making this happen because if it were not for Pete, it would not have happened and Frank for coming down Thank you.

Pete introduced: Robert Martin Upper Cumberland Chapter Vice President that had brought Nick Marotta with him. As a Vice President you fill in when the President cannot, or when they can't find a volunteer, they always turn to the Vice President. Our chapter is the average age 76 membership. We have tried meetings at different times to see what fits for our chapter. We bring in local members of the community as guest speakers. We support ROTC units in our area. Within the community we will go out and speak about MOAA wherever we can get invited. And then we have the comradery of the group. My recommendation would be once you get up and running is find what your interest is, and what works best for your chapter and press on. Engage in your community.

Pete introduced Larry Ellis Stones River Chapter Membership Chair. He wanted to mention he was glad to know that at 78 he was of average age, and he appreciates that. Recruiting to me makes no difference between recruiting and retention. He shared a story to never let an opportunity to recruit go to waste. He mentioned that guest speakers need to benefit the group. Brought up the chapter takes trips and tours, and the treasurer is instrumental in that. Brought up important positions like the Secretary that keeps the membership informed. Retention and Recruiting getting the word out.

Pete thanked the team for coming to support this chapter and mentioned Mary Boring who set everything up in this room, was a 12-year Marine veteran and survives the passing of her spouse who also was a Marine. Without her this room would not have happened. He went on to coin Mary Boring and Sandy gave her a TN Council of Chapters pen which has the Tennessee Council website on it.

Pete stated that this gets him to the point of why you all are here today. To get this chapter up and organized and that means today. We have Frank here and an installation script for the President, Vice President, Membership Chair, Treasurer and Secretary if you will all raise your hand and want to do this.

During the Q & A Pete explained the catchment areas in the state of Tennessee and that this area has 11 counties in its catchment area. He quoted stats of Tennessee and we rank 14 in the country in veteran population.

Policy and Procedures were brought up and the general guidelines brought out which also can be accessed online. The secretary caught up with the vote and the Charter was mentioned. We have an existing Charter for this chapter, and we do not have to wait a year for the National board to approve it. Start with the Policy and Procedures Guide and amend along the way.

Pete went on to explain the importance of the Membership chair and there is no requirement to be a CPA to be the treasurer.

The officers filling positions were called up and sworn in by Frank he asked Chaplain John Woods to say a prayer over the installed Board and members of this chapter. This ended the meet and greet, those in attendance came together to create a board for the East Tennessee Chapter TN02. Frank Michaels performed Installation Ceremony at the closed of the meeting.
