Acceptance of Minutes

Minutes of the 16 April 2025 meeting had been sent out on 24 April 2025 to all the chapter presidents and Council members Don Thompson moved that the minutes be accepted. The motion was seconded by Larry Cotton and approved unanimously.

Financial Report

The financial report for the period of April 1, 2025, to June 30, 2025.

The council had two disbursements during the quarter, to Pete Warner for travel expense to speak at TN12 General Andrew Jackson Chapter reimbursement of \$138.60 and travel expense to speak at TN02 East Tennessee Chapter aka SMC \$229.60.

The council had no deposit from MOAA National.

Total funds on hand at the end of the quarter were \$4,995.13, which included restricted travel funds of \$226.13.

MOAA Surviving Spouse Virtual Chapter June 2025 Newsletter reported the following Office of Survivor Assistance changes taking place at the VA:

- VA Office of Survivor Assistance (OSA) moved in June from Veterans Benefits Administration to the Office of the VA Secretary. This reverses a Biden era decision that buried OSA under layers of bureaucracy.
- VA will create a "white glove" survivor outreach team to guide and assist eligible survivors throughout their DIC process.
- VA will begin to work immediately to identify areas where automation can be used to make the DIC claims process easier for survivors to navigate.

VA Secretary Doug Collins said, "The last thing survivors need in their time of grief is frustrating red tape and bureaucracy. That is why we are creating a better system to more quickly and effectively provide survivors the services, support, and compassion they have earned."

ADVOCACY/LEGISLATION

Please refer to the April 16, 2025, TN Council of Chapters Minutes for sponsors and more details about the legislation below:

 H.R.2055 and S.611- "Caring for Survivors Act of 2025" are to expand Title 38, United States Code, to improve and expand eligibility for the Dependency and Indemnity Compensation (DIC) paid by the VA to surviving spouses and others whose veteran died on active duty or from a service-related injury/illness. This legislation would increase DIC from 43% of a single, 100% disabled veteran's compensation to 55%.

H.R.2055 has 83 <u>co-sponsors</u> (1 TN: S. Cohen (TN-09) S.611 as <u>2 co-sponsors</u> (NONE from TN)

2) <u>H.R. 1004 and S.410</u> - <u>"Love Lives on Act 2025"</u> would allow retention of Survivor Benefit Plan (SBP) through the Department of Defense and Dependency and Indemnity Compensation (DIC) through the VA upon remarriage at any age; and allows remarried surviving spouses to regain their TRICARE benefits if their subsequent marriage ends due to annulment, divorce, or death.

Currently, surviving military spouses are not allowed to remarry before the arbitrary age of 55 without losing ALL their benefits.

H.R.1004 has 72 <u>co-sponsors</u> (NONE from TN) S.410 has <u>42 co-sponsors</u> (NONE from TN)

Please encourage <u>all</u> MOAA chapter members, spouses, and surviving spouses to contact their Congressmen and Senators to advocate for legislation impacting our surviving spouses as follows:

Contact your Congressman and Senators, using the MOAA Capitol Switchboard (1-866-272-6622), ask to be connected to your Congressman or Senator's office, once connected ask to speak with the Military Legislative Assistant (MLA). Follow up your phone call with an e-mail to the MLA. Please use the updated (3/20/25) TN Congressmen and Senators Contact List provided with the April TN Council of Chapters Minutes for the MLA name and e-mail.

You may also e-mail your Congressman or Senators directly via their website.

You may also request to visit your Congressman or Senators at their District Office during their August recess.

Please <u>do not</u> use USPS to contact congressional leaders. USPS mail is screened off site before delivery and prolongs delivery time!

ALERT: All MEDICARE/TRICARE FOR LIFE beneficiaries are reminded to check their Explanation of Benefits (EOB) "carefully" upon receipt.

Patricia had 6 items of durable medical equipment on a recent EOB which she neither needed or received, nor did she recognize the provider. Fortunately, TRICARE FOR LIFE did not pay the claim, but MEDICARE did.

Upon calling TRICARE FOR LIFE, she was told there had been a rash of these fraudulent claims submitted recently. They have flags in their system, but MEDCARE does not and must be notified!

If anyone finds claims on their TRICARE EOB for services they did not receive from an unrecognized provider, call TRICARE to report it. Then, TRICARE will connect you to MEDICARE to report it so that they can send to their Fraudulent Claims and Abuse Department.

Legislative Laison Update: Bill Summers provided updates from last Saturday's meeting 12 July 2025.

II. Advocacy

• CDR Ted Edwards, USN (ret.), our Legislative Officer attended the Advocacy in Action in April and reported on the experience and results.

Each monthly newsletter included a Legislative Update and the President's Letter discusses how
to use MOAA's Legislative Action Center for individual advocacy. Legislative Advocacy was also
discussed at the end of each monthly luncheon with a summary of timely issues and emphasis
on individual participation in the LAC.

II. Community Outreach

- The chapter received approval for a Community Outreach grant for 2025 to support the annual Holiday Market sponsored by Operation Stand Down Tennessee to alleviate food insecurity among veterans in Middle Tennessee. The chapter will distribute \$50 Publix gift cards during the Holiday Market. These cards can only be used for food purchases at Publix.
- The chapter held is annual Memorial Day Commemoration at the Middle Tennessee State Veterans Cemetery on Saturday, 24 May. A wreath laying for veterans from each service who lost their lives in service of the nation was conducted and brief remarks were delivered. We also remembered chapter members who had died since last years' service.
