### The Current Political Landscape in the World

#### By Mr. Van Hillary

Van Hilleary grew up in the small town of Spring City, TN, located halfway between Knoxville and Chattanooga.

He is a graduate of The University of Tennessee with a B.S. in Banking and later received a law degree from Cumberland School of Law in Birmingham, AL.

After graduation from UT he entered the U.S. Air Force and became a navigator on C-130 aircraft. After active duty, he went to work for his family's textile business in Spring City, which he then left to attend law school. The day after his law school graduation in 1990, he volunteered for service in the Air Force Reserve during the first Gulf War - Operations Desert Shield and Desert Storm. While deployed to the Persian Gulf, he earned 2 Air Medals, the Kuwait Liberation Medal, the National Defense Service Medal, and the Southwest Asia Service Medal.

In 1992 he ran for Tennessee State Senate against the matriarch of one of Tennessee's powerful Democrat families at the time, Senator Anna Belle Clement O'Brien of Crossville. Although it was announced that he won on election night, additional votes were found overnight in Overton County, and by morning he had come up just short.

However, his strong showing in the state senate race caught the eye of Republican leaders in Nashville, who recruited him to run for TN's 4<sup>th</sup> Congressional District in 1994, when Cong. Jim Cooper left the seat to run for U.S. Senate against Fred Thompson.

Even though the 4<sup>th</sup> congressional district had been held by the Democrats since the post-Civil War Reconstruction period, Hilleary won on election night, as did many other Republicans across the country running for Congress, and the House of Representatives became majority Republican for the first time in 40 years.

He served on the Armed Services Committee, the Education and Labor Committee, and Budget Committee, where he helped balance the federal budget for four consecutive years - the only times the federal budget has been balanced in the last 62 years.

In 2002, after 8 years in the House of Representatives, Hilleary ran for Governor of Tennessee on an anti-income tax and proeducation platform. He lost to then-Nashville Mayor Phil Bredesen in the closest race for governor in Tennessee since the 1800s

He later served a term as TN's National Committeeman on the Republican National Committee.

After working as a lawyer/lobbyist for a number of years, in 2018 he accepted a position with his longtime friend and newly elected 6<sup>th</sup> District congressman, John Rose, as his Chief of Staff, serving in Washington when Congress is in session and in Tennessee - out of the Gallatin office - when Congress is in recess.

He lives in Hendersonville with his wife of 25 years Meredith and the three youngest of their four children who are still living at home.

Let's make him feel welcome!

## Possible Tricare For Life &/or Medicare Fraud

From Patricia Bergquist: remind all members to check their TRICARE FOR LIFE Explanation of Benefits (EOB) "carefully" upon receipt.

I personally had 6 items of durable medical equipment on my recent EOB which I did not either need or receive. Never heard of the company. Fortunately, TRICARE did not pay the claim, but MEDICARE did. Upon calling TRICARE FOR LIFE, I was told there has been a rash of fraudulent claims submitted recently. TRICARE has flags in their system, but Medicare does not! Medicare must be notified.

If anyone encounters charges on their TRICARE EOB which they did not receive or know about, call TRICARE and they will

then connect you to Medicare to report the "fraud".

#### **LEGSLATIVE ACTION**

The following is verbatim from the MOAA website:

## Retirees & Veterans

MOAA NEVER STOPS SERVING WELL BEYOND THEIR MILITARY CAREER.

Veterans and transitioning servicemembers face unique challenges once they have left the military: second and non-military careers, reinventing themselves, retirement concerns, navigating veteran benefits and health care, and access to support programs and networks. MOAA will focus on capitalizing on our recently released report, Ending the Wait for Toxic-Exposed Veterans, to advocate for veterans exposed to toxic materials during their service. While the Sergeant First Class Heath Robinson Honoring Our Promise to Address Comprehensive Toxics (PACT) Act has made major improvements to how toxic exposures are treated by the VA, additional measures are required.

#### MAJOR RICHARD STAR ACT

Contact your legislators and urge them to support the Major Richard Star Act, which would authorize combat-injured veterans to receive their earned DoD retirement pay for years of service and their VA disability compensation for lifelong injury.

Currently, these combat-injured (and often seriously disabled) veterans are subject to a cost-saving offset where their retirement pay is reduced for every dollar of VA disability received. To reduce earned retirement pay because of a combat disability is an injustice; the compensation for

these injured veterans is not the place to achieve savings.

#### TOXIC EXPOSED VETERANS

Veterans exposed to toxic substances like Agent Orange, chemicals released by burn pits, and radiation should not have to fight for decades to prove their illnesses are service-connected. Yet according to a recent report from MOAA and DAV, toxic-exposed veterans wait over 34 years on average before receiving presumptive service connection and the care they've earned. The PACT Act was a historic step forward, but its work isn't complete.

Congress must pass legislation to bolster the legal framework for establishing presumptive conditions, creating clear timelines and processes to move from exposure acknowledgment to the delivery of earned benefits. This common sense reform will cut through red tape, improve VA accountability, and end the long wait faced by millions of veterans.
